To become recognised breeders, Dogs West members have to sit an exam with a pass rate in Section A of 100% and Section B 90%, and have to be members for a period greater than 12 months, to even qualify to be breeders.

The council/ government cannot monitor this, but Dogs West can. Therefore, only registered members of Dogs West should be able to breed dogs.
