Background

Section 27F of the *Betting Control Act 1954* (BC Act) provides that a domestic betting operator is authorised to publish Western Australian race fields, subject to the requirement that it must, within the period prescribed in the *Betting Control Regulations 1978* (Regulations):

- lodge a return showing the total bets it has taken on WA races, and
- pay the relevant race bets levy (RBL).

A domestic betting operator means a person who in this State or another State or Territory is authorised to engage in or conduct the business of betting. That is, a domestic betting operator is a bookmaker, an off-course totalisator, an on-course totalisator or an operator of a betting exchange. A domestic betting operator does not need an approval but must provide evidence that they hold a current licence in order to be registered for WA race fields and pay the racing bets levy.

An offshore betting operator is a person authorised under the law of a jurisdiction outside Australia to engage in or conduct the business of betting. Offshore betting operators must apply to the Gaming and Wagering Commission for approval (s27D of the BC Act refers).

Approval would (generally) be subject to the same conditions as a domestic betting operator, that is, lodgement of an RBL return and payment of the relevant RBL. Offshore betting operators must be approved by the Gaming and Wagering Commission before they can offer betting services on Western Australian races.

Betting turnover is defined in s14A of BC Act as follows:

- for a domestic betting operator (but not the operator of a betting exchange) or an offshore betting operator, the total amount of racing bets placed with the operator, less the amount of bet backs placed by the operator.
- for a betting exchange, the net winnings of racing bets placed with the betting exchange.

Gross revenue is defined in s14A of the BC Act as follows:

- for a domestic betting operator (but not the operator of a betting exchange) or an offshore betting operator, the turnover of the operator, less any dividends to customers by the operator on racing bets, and
- for the operator of a betting exchange, the charges, commission, consideration, earnings, fees, reward or other remuneration (however described) payable to or received by an operator in relation to racing bets placed with, or placed and accepted through, the operator.

The levy payable for racing bets is prescribed in the *Racing Bets Levy Regulations 2009* (RBL Regs). The rates are structured so that all betting operators pay a fixed levy of 1% of turnover until their turnover reaches \$3M (threshold). Turnover is aggregated from 1 August to 31 July and the \$3M threshold re-sets on 1 August each year, which is the beginning of the racing year.

Once turnover exceeds \$3M, the RBL rates differ depending on the type of betting operator, whether bets are pari-mutuel or fixed odds and whether bets are taken on standard or premium race meetings. Betting operators whose turnover does not exceed \$1,000 in any month, do not pay a levy for that month, but must still lodge a return.

The current RBL rates have been in place since 1 August 2018 and are as follows:

Pari-mutuel bets

Below \$3M	1% of turnover
Above \$3M (standard race meeting)	2% of turnover
Above \$3M (premium race meeting)	2.5% of turnover

Betting Exchange

Below \$3M	1% of turnover
Above \$3m (standard or premium race meeting)	31.8% of gross revenue

Fixed Odds

Below \$3M	1% of turnover
Above \$3M (standard race meeting)	the greater of 2% of turnover or 13.6% of gross revenue.
Above \$3M (premium race meeting)	the greater of 2.5% of turnover or 22.7% of gross revenue.

Premium race meetings are defined in the RBL Regs as follow:

- Thoroughbred racing – any meeting containing at least one race with stake money of \$100,000.
- Harness racing – any meeting containing at least one race with stake money of \$50,000.
- Greyhound racing – any meeting containing at least one race with stake money of \$30,000.

Registration and Lodgement of Race Bet Levy Returns

Domestic Betting Operators

A domestic betting operator who proposes to take bets on WA races should contact the Department in the first instance by email at rgl@dlgsc.wa.gov.au or by telephone on (08) 6551 4888.

To register for WA race fields, the operator must provide the Department with a copy of their current Australian wagering licence and details of any approved trading names under which it is permitted to trade.

Offshore Betting Operators

Offshore betting operators must be approved by the Gaming and Wagering Commission before they can offer betting services on Western Australian races.

They should contact the Department to find out the process for being approved by email at rgl@dlgsc.wa.gov.au or by telephone contact on 618 6551 4888.

Account Creation

Once the registration/approval process has been completed, the wagering operator must create an online account with the Department to enable lodgement of RBL returns. The account is created via the portal at <https://portal.dlgsc.wa.gov.au/>.

Before creating an account, please note:

- Mobile devices and Safari are not compatible.
- Your operating system should have the latest security updates installed.
- You should have anti-virus software installed and updated.

Please create the account under the licensee name.

Creating an account:

1. Go to [Racing, Gaming & Liquor Portal](#)
2. Click on Create Account in the top right hand corner.
3. Enter a username, email address and password as indicated.
 - Creation of usernames requires lowercase only, with a minimum of 5 and a maximum of 20 characters. The username must NOT contain spaces or symbols (ie @!) and can't be an email address
 - The password must contain: Minimum 10 characters with at least 1 uppercase and 1 lowercase character, and 1 number. Special character: \$, @, !, *, ?, & are permitted
4. Click 'No' to indicate you are not an existing customer.
5. Click Register
6. Go to your email inbox to verify your new account using the email we have just sent you.

- Click on the link in the email to verify the account.
 - The email should arrive within 5 minutes. If you have not received the email, please check your JUNK or SPAM folder
7. Log in to your account using your new username and password.
 8. Please refer to the information pack page 4 and 5 on how to lodge the return through the portal.

Once this is done, an email will be sent to the email address provided. Open the registration email and **click on the registration link**.

Complete an “applicant details form” as follows prior to lodging your first racing bets levy return.

1. In the menu bar at the top of the page click on New Lodgement to locate the online return forms.
2. From the drop-down menu, select the Group as Racing.
3. Choose the type of Racing Bets Levy return you are completing (Bookmaker, On Course Totalisator, Off Course Totalisator or Betting Exchange).
4. Click on **Submit** to start the form.
5. Ensure you read the Instructions page.
6. Please note you cannot save this form and return to it later; it must be completed in full and submitted to properly set up the account or make any changes to your existing contact details. If you must exit the form, you will need to restart this process when you return to this point.
7. Click on submit to complete the process. The system will create an applicant reference number which you should quote if you have any queries to discuss with us.


Lodgement of Returns

The purpose of this lodgement guide is to provide guidance for wagering operators to lodge their Racing Bets Levy Return online via the Department’s website portal.

In accordance with section 14A(2) of the Betting Control Act 1954, wagering operators must lodge a return and pay the levy within 14 days of the end of the calendar month.

The following steps provide guidance in lodging your return online.

1. If you are lodging a return at the same time as creating your account, click on “continue” to proceed to the Return form. If you click on continue and it does not automatically start the next form please return to New Lodgement, select the form type again (Bookmaker, On Course Totalisator, Off Course Totalisator or Betting Exchange), and choose to skip the Applicant Details form to proceed.
2. If you are lodging your first return on a later occasion, log into your account and select “New Lodgement”. Choose *Racing* in the *Group* option and then the appropriate wagering operator return type as shown below. Hit submit.



- If entering manually, proceed to the race details page and enter relevant details as shown below. You will need to enter details for each race and each race meeting (the csv upload file will automatically populate each page). This method of lodgement is only recommended for “nil” returns or returns involving a minimum number of races.

Tip:

On the first occasion you lodge a return, it is highly likely that the system will show a message that indicates you cannot proceed as you have outstanding returns to lodge. This is because the system is programmed to ensure that returns are lodged in chronological order for each racing year (August to July). Nil returns will be required to be lodged from August for the system to accept your latest returns. When this occurs, you must lodge “NIL” returns for all the preceding months. Please contact the Racing Bets Levy team at rbl@dlqsc.wa.gov.au if you require assistance with this process.

Layouts for Racing Bets Levy Return upload data files from 1 August 2018

There are four layouts, one for each operator type (Bookmakers, Betting Exchanges, On Course Totalisators and Off Course Totalisators).

Types of rows

The file must be made up of three kinds of rows, (H)header, (D)etail and (F)ooter. See the layout below for details of each kind.



Order

The (H)header row must be the first row, followed by the (D)etail rows and then the (F)ooter as the last row. The detail rows must be ordered according to Race Club, Race Date and then Race No.

Date and Code

The file must be in date order and in the following code order - Thoroughbreds (T), Greyhounds (G) and Harness(H). Files that are not in this order will not upload.

Separation of columns

Columns (fields) must be comma separated (CSV). Note that creating the files in a spreadsheet program and saving as CSV is fine. It may create extra commas at the end of the header and footer rows but the upload facility will correct that.

File name

Please ensure that the file to be uploaded is named as follows:

Racing Bets Levy Return <month>.csv

(where <month> is the applicable month the return applies to - YYYYMM format)

Sample: **Racing Bets Levy Return 201812.csv**

Tips for creating these files:

If you are creating them in a spreadsheet program, you can set up formulas to calculate the correct numbers. When you save the files as .csv, the formulas are removed and the value remains.

If you enter Nov09 or 11/2009 or Nov/09 in Microsoft Excel, it will convert that to Nov-09 which is a valid format for submission. If you enter Nov/09 or Nov-09 in Google Docs, it will format it incorrectly. Use Nov09 or 11/2009.

WA Race Fields - Policy

Disclaimer

This [WA Race Fields policy](#) is intended to provide information on the subject matter covered, and with the understanding that the Gaming and Wagering Commission is not offering a legal opinion or interpretation or other professional advice. The information is provided on the understanding that all persons undertake responsibility for assessing the relevance and accuracy of its contents.

Purpose

The purpose of this policy is to describe the requirements of betting operators who use or publish WA race fields as part of their wagering operations.

Legislative Basis

The racing bets levy scheme is achieved through the *Betting Control Act 1954*, the *Racing Bets Levy Act 2009*, the *Betting Control Regulations 1978* and the *Racing Bets Levy Regulations 2009*.

Approval to Use WA Race Fields

Under section 14A(2)(b) and 27D(4A) of the *Betting Control Act 1954* ("the Act"), the use of Western Australian race fields is subject to the payment of a racing bets levy and the provision of prescribed information. Betting operators who are licensed in Australia are automatically entitled to use/publish WA race fields under this legislation, subject to the provision of prescribed information and payment of the racing bets levy to the Gaming and Wagering Commission.

Section 27D(2A)(b) of the Act requires offshore betting operators to seek approval from the Gaming and Wagering Commission in order to use/publish WA race fields. The application form can be downloaded [here](#) or is available from the Department of Racing, Gaming and Liquor.

Racing Bets Levy

The racing bets levy regime came into effect from 1 September 2008 and there have been various rates and methods of payment since that time. The current levy regime, which came into effect from 1 August 2018, is a differential racing bets levy structure in which a base rate levy of 1% is charged for all turnover up to and including \$3,000,000. Thereafter, standard race meeting and premium race meeting levy rates apply as follows:

- Pari-mutuel bets placed on standard race meetings levied at 2% of turnover.
- Pari-mutuel bets placed on premium race meetings levied at 2.5% of turnover.
- Betting exchange bets placed on standard race meetings levied at 1.5% of turnover.
- Betting exchange bets placed on premium race meetings levied at 2.5% of turnover.
- Fixed odds bets placed on standard race meetings levied at the greater of 2% of turnover or 13.6% of gross revenue, calculated for each race meeting.
- Fixed odds bets placed on premium race meetings levied at the greater of 2.5% of turnover or 22.7% of gross revenue.

Premium race meetings are defined in the regulations on the basis of the value of stake money on offer, as follows:

- Thoroughbred racing – any meeting that contains at least one race with stake money of \$100,000;
- Harness racing – any meeting that contains at least one race with stake money of \$30,000;
- Greyhound racing – any meeting that contains at least one race with stake money of \$30,000.

Wagering operators who generate turnover of less than \$1000 in any month are required to lodge a return but are exempt from paying any levy in that month.

Turnover

Turnover is defined under section 14A(1) of the Act as:

“turnover means-

- (a) in relation to a domestic betting operator or offshore betting operator – the total amount of racing bets placed with the operator, less the amount of bet backs placed by the operator;*
- (b) in relation to a betting exchange – the net winnings of racing bets placed with the betting exchange.”*

A bet back is defined in section 14A(1) of the Act as:

“bet back means a bet placed with a domestic betting operator, or the operator of a betting exchange, if the bet is placed –

- (a) for the purpose of reducing the liability of another domestic betting operator; and*
- (b) by that other domestic betting operator”.*

Turnover:

- a) is not reduced by:-
 - i) rebates paid to customers or discounts offered to customers;
 - ii) any amounts paid to commission agents;
 - iii) bad sales;
 - iv) bad debts, errors and customer claims;
- b) excludes jackpots (transferred from other pools) and any amounts added (seeded) to the pools by the Wagering Operator;
- c) includes the value of free bets;
- d) in the case of doubles bets and multi bets, add to turnover the proportion of the amount bet equivalent to the proportion of the bet placed on WA races (i.e. if one of two legs is a WA race, then 50% of the value of the bet is attributed to WA turnover);
- e) in the case of an all-up bet each leg of the all-up is a separate bet. Therefore, turnover should be recorded for each separate transaction as each leg is completed;
- f) any bets placed that cross a reporting period are to be apportioned as they relate to each reporting period.

Gross Revenue

Gross revenue is defined under section 14A(1) of the Act as:

“gross revenue means –

- (a) in relation to a domestic betting operator or offshore betting operator – the turnover of the operator, less any dividends to customers by the operator on racing bets;*
- (b) in relation to the operator of a betting exchange, the charges, commission, consideration, earnings, fees, reward or other remuneration (however described), payable to or received by an operator in relation to racing bets placed with, or placed and accepted through, the operator”.*

Therefore, gross revenue in relation to a domestic or offshore betting operator includes the income derived from betting on races conducted in WA, whether placed with or through the betting operator, less the amounts payable in respect of winning bets, with any other costs incurred by the betting operator not being deductible. The derived income includes any commissions or fees charged in relation to the bets or winnings and unclaimed dividends will also form part of the betting operator's gross revenue.

Gross revenue is not reduced by any betting tax, GST or pooling fees paid. Essentially, gross revenue is defined as turnover less winnings paid.

For betting exchanges, gross revenue is effectively the commissions taken from the customer's net winnings on a market.

Prescribed Information Requirements

In addition to the levy, betting operators must supply 'prescribed information' on betting transactions conducted on WA races to the Gaming and Wagering Commission, under section 27D(4A) of the Act. Regulations 103 and 106 of the *Betting Control Regulations 1978* ("the regulations") define prescribed information as information in documents, records or accounts relating to racing bets placed with or placed or accepted through, a betting operator.

Under regulations 104-108, betting operators must comply with the Chief Steward of RWWA and authorised officers of the Gaming and Wagering Commission by allowing them to:

- view any document, record or accounts of the operator containing prescribed information;
- provide them with a copy of any document, record or accounts containing the prescribed information; and
- where possible, provide real time access to betting systems.

Section 27E(3) of the Act requires that the information be provided to RWWA in a summary or statistical format and that it does not directly associate the betting operator with the data.

WA Race Fields Return

The legislation requires that all betting operators who publish/use WA races, to lodge a monthly race fields return (and pay the racing bets levy) within 14 days of the end of each month. The return must be completed in a form approved by the Commission under section 14A(2)(a) of the Act. In this regard, the return can be submitted via the online system (available by accessing the RGL website) or on a manual form, available by contacting the department. The information required in the return includes:

- Race meeting date
- Race code (i.e. thoroughbreds, harness or greyhounds)
- Race club conducting meeting
- Race number
- Total bets taken through each sales channel (i.e. on-course, telephone, internet and retail)
- Total amount of bets taken
- Total amount of pay-outs

Payment Methods

Once the levy is calculated, payment can be made using the following methods:

- BPay; Electronic Funds Transfer (EFT); Credit/debit card (either online or by printing a remittance slip and posting the details).

WA Race Fields – Annual Audited Return

Annual Audited Return

Regulation 110 of the regulations requires that an annual, audited return completed independently by a qualified auditor¹, covering the previous race year (1 August-31 July) be submitted to the Gaming and Wagering Commission by 30 August each year. This return must specify the total amount of turnover on WA races and, the total amount of levy paid on those bets (excluding GST) for each month.

Betting operators may be granted an exemption from this requirement if they meet the following criteria:

- total turnover for WA races is less than \$50,000 per annum; and
- total turnover for WA races is less than 10% of the operator's total annual turnover.

Betting operators must write to the Gaming and Wagering Commission to request an exemption and to provide details of:

- total amount of turnover on WA races for the year;
- the percentage of total annual turnover that applies to WA races; and
- the reasons for the exemption request.

If required, an exemption must be sought on an annual basis.

The annual return form is enclosed and must be completed and signed by the wagering operator as well as a person who is independent to the wagering operator and qualified to conduct an examination of records to form an opinion about the authenticity and correctness of such records, such as an accountant or auditor.
